City Administrator Young:

I am writing to express my grave concerns regarding statutorily required reports that are grossly overdue for submission to the D.C. Council ("Council"). As Chairman for the Committee on Education it is my duty to oversee compliance of the law by agencies within my purview. In recent months and weeks, I have made multiple requests for overdue reports from both the Deputy Mayor for Education and agency leadership. It is not only frustrating, but alarming that laws are not being followed and deadlines are not being met.

I am requesting that you release the following reports and officially submit them to the Council by close of business this Friday, January 12, 2018:

- **The Capital Improvement Plans for School Modernizations**
  - A comprehensive 10-year Master Facilities Plan for public education facilities (D.C. Code § 38-2803(a)(1) due to the Council on December 15, 2017);
  - DCPS's calculation of a final prioritization score for each school facility in its portfolio (D.C. Code §38-2803(d)(3)(B)(i) due to the Council on September 30, 2017);
  - DCPS's prioritization scores and raw data (D.C. Code §38-2803(d)(3)(C) due to the Council by September 30, 2017).
  
- **Title IX Compliance Report**
  - D.C. Code §38-841.03 due to the Council on October 31, 2017.
  
- **Shaw Middle School Report**
  - As part of the FY17-18 Committee on Education budget oversight hearings and the subsequent report, the Committee recommended a report on the



Chancellor's ideas for the Shaw Middle School site by October 15, 2017.<sup>1</sup>

- **State of Discipline Report**
  - D.C. Code §38-236(d) due to the Council on December 15, 2017.
  
- **State of Pre-K Report**
  - D.C. Code §38-271.05 due to the Council on December 30, 2017.
